

## **PRIVATE INVESTIGATOR AND SECURITY GUARD HEARING BOARD VACANCY**

The Licensing Unit is now taking applications and résumés for a Hearing Board vacancy. We will be accepting applications and resumes to fill the following vacancies:

- Two positions representing the Security Guard Industry (1 five-year term that expires January 20, 2031 and 1 one-year term that expires January 18, 2027)
- Two positions representing the Private Investigations Industry (2 five-year terms that expire January 20, 2031)

Applicants must be a:

1. U.S. citizen,
2. Resident of this state at the time of appointment,
3. Qualifying Party (License Holder)

To be considered, please submit your application by 5:00 pm on October 31, 2025.

The Security Guard and Private Investigator Hearing Board is comprised of seven members: two from the security guard industry, two from the private investigator industry, two from law enforcement agencies, and one public member.

Hearing Board members serve a staggered term of five years. The Board typically meets 8-9 times for scheduled hearing dates throughout the calendar year. The Hearing Board makes decisions on appeals to denials of security guard, private investigator and agency licenses; the granting of good cause exceptions for misdemeanor and felony offenses; and makes recommendations to the Director regarding disciplinary action.

The Hearing Board meets in the Arizona Department of Public Safety, Access Integrity Training Room, located at 2222 West Encanto Boulevard in Phoenix.

If you are interested in serving as a Board member, please submit your application and résumé to the Licensing Unit. Your résumé should include your experience in the security guard and/or private investigator industry, your education, and if you have served or currently serve on another board.
