- 8. **Update on 925 Emergency Rule** Chairman Nicholas Franklin advised that Mr. Paul Swietek was unavailable to attend the meeting to provide an update regarding the 15-925

- 11. Chairman Nicholas Franklin discussed how we will move forward with study groups. Currently we have approximately 90 individuals who have submitted the study group applications for consideration.
- 12. Captain Vern Havens gave a high-level overview of Article 1- School Bus Minimum Standards and Article 2- School Bus operators, Electric Hybrid and Alternate Vehicles.
- 13. Jason Nelson also addressed concerns with the current instructor manual dated in 2011 and how this should be a priority with one of the study groups.
- 14. Captain Vern Havens talked about future agenda items; we will not have a scheduled STAC meeting in December.
- 15. **Schedule future meeting-** Chairman Nicholas Franklin stated we have future meetings scheduled to ensure availability. The next scheduled meeting is set for January 14, 2026, at 10:00am MST.
