   be required. Verify amount needed before submitting payment. Fees are not refundable per A.R.S. §41 1750(J).
- 3. PHOTOCOPY OF DRIVER'S LICENSE OR GOVERNMENT-ISSUED ID Photocopy must be legible.
- TRAINING VERIFICATION FORM
   Complete all applicable sections of the form. The form must be signed and dated.
- 5. PASSPORT STYLE 2"X2" COLOR PHOTO Facial photographs must be in focus, and headshot with white background.
- 6. FINGERPRINT CARD (\$22.00 processing fee) FD-258 (Blue Card)
- PROOF OF US CITIZENSHIP OR LEGAL RESIDENCT AUTHORIZED TO SEEK EMPLOYMENT IN THE UNITED STATES.
   Provide a copy of US Citizenship or Legal Resident Card.
- 8. COPY OF DD214 (Armed only) If you have served in the United States Armed Forces, you must provide a copy of your DD214 showing the conditions of your discharge.

# NOTE: <u>IF ITEMS #1, #2, OR #6 ARE MISSING OR INCOMPLETE, YOUR APPLICATION PACKET WILL BE</u> RETURNED WITHOUT PROCESSING.
